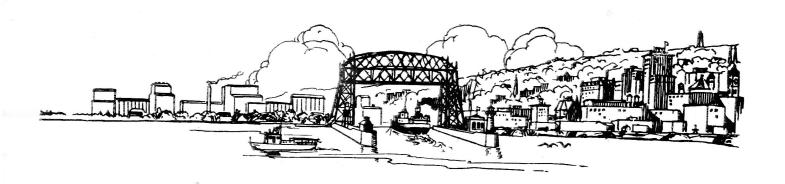

NATIONAL NEWS

Work continues on the Public Relations 'Tag Program' in which members of the National Marine Manufacturer's Ass. will affix 'Tags' promoting the USPS Boating Course to members of the public who buy various items of marine equipment. Orders for over one-half million tags have already been received by Headquarters. When the initial shipment of the new tags is received by Headquarters, it will mail samples to each squadron and district for their review.

Safe Boating Week is of added interest this year because R/C Robert A. Green, N, has been named National Chairman for 1986. (Hopefully he will do a better job!)

V/C Rogers cited Boating Course statistics showing a continued increase in numbers of students taking the Course, from 26,924 in 1983, to a projected approximately 40,000 in 1985.

Several Supplemental Programs are under development, including Compass Adjusting, Calculators for Navigation, Insurance for Boats, Preparations for Coast Guard Licensing and others.

It was reported on the important role played by Port Captains in the Canadian Power and Sail Squadrons, as much as 20% of their Boating Course attendance can be attributed to referrals by Port Captains, who are actively advertised through the placement of posters in marinas and other boating and yachting locales.

The Operating Committee Approved a proposed ENSIGN program to promote advertising sales and augment squadron income. The program will involve assigning prospective advertising accounts to individual members, and giving that member's squadron a 10% commission on advertising space sold.

HOW MANY ARE ENOUGH IN APOSTLE ISLANDS?

The Apostle Islands in Lake Superior attract thousands of people every year. Most come in private boats, seeking the solitude of a wilderness island anchorage. The National Park Service, which administers many of the islands, wondered just how many boats and people can cruise the islands without fear of overcrowding. So, the University of Wisconsin was commissioned to do a study of public attitudes.

Sociologists examined the impact of additional permanent dockage as well as other factors influencing people's perceptions of overcrowding. They concluded that 100 to 200 additional slips in the region would not stimulate enough boating activity to invoke negative reactions, at least not during mid-week.

However, adding 400 new slips would cause problems, especially on weekends. Another interesting discovery is that people using Apostle Islands already consider them 'Crowded' even though there is a relatively low boating intensity there.

- Q. What is the best type of fire extinguisher to buy for your home?
- A. A multipurpose, dry-chemical, Class ABC fire extinguisher is considered by most authorities to be the best choice for home use. To explain why, you should know that fire extinguishers are classified according to the type of fires they can effectively and safety extinguish.

Class A fire extinguishers are used on wood, textiles and paper rubbish, etc.

Class B fire extinguishers are used on flammable liquids such as, grease, gasoline, etc.

Class C fire extinguishers are used on live electrical equipment.

A multipurpose Clase ABC fire extinguisher is therefore suitable for extinguishing all three types of fires.

WEATHER OR NOT-IT'S ON APPEAL

A landmark court decision finding the National Weather Service liable for the storm-related deaths of three Cape Cod fishermen has resulted in a \$1.25 million award to the families of the three men.

The August decision, however, could be overturned as the federal government appealed the ruling Oct. 1st. The appeal was filed in U.S. Circuit Court in Boston where the original suit against NWS was heard. The decision was controversial because it found the government weather service at fault for not accurately tracking the course of a sudden severe storm in which the fishermen perished in November 1980.

The storm was not forecast because a critical data-collecting buoy on the Georges Bank off Cape Cod was not working and had been left unrepaired for two months. The judge ruled the NWS had 'induced' mariners to rely on it for accurate weather information and had an obligation to keep equipment working or issue a warning that forecasts were based on incomplete data. The government argued that a forecast is nothing more than a prediction. The decision raised serious questions of liability for many private weather forecasting companies as well as individual meteorologists, such as those who issue forecasts on TV and Radio.

Arguments for the appeal are not expected to be heard until February.



BOAT THEFTS

The following precautions may help prevent boat thefts.

Remove the key from the ignition when the boat is not in use.

If the boat is moored in the water unattended remove and store the battery in a locked building or in the trunk of your car.

When parking a trailered boat, attach the trailer hitch lock. If parking for a long time, remove a wheel. Fasten the boat itself to a fixed object with a steel cable or chain and heavy-duty lock.

If using a marina, choose one with good lighting and a full-time security guard. Wire a theft alarm to the ignition, with a second, hidden switch in case a thief jumps the first one.

At home, keep your boat in a locked garage or a fenced yard with a heavy padlock.

Do not leave a FOR SALE sign on the boat; someone seeing a thief at work might assume that they bought the boat.

Do not leave valuable documents, such as the boat registration and title papers, in an unattended boat.

Record all serial and identification numbers and keep them at home. Hide a second set of numbers somewhere on the boat so you can prove ownership if thieves remove the original set.

Take a color photo of the boat from different angles. These may be used to recover losses under a boat owner's insurance policy and to help police identify a stolen boat.

LEARNING WHAT'S HAZARDOUS

People who work around hazardous substances owe it to themselves and their families to know what's in the materials they are exposed to and what, if any, health effects may be involved.

A good way to do this is by understanding how to read a material safety data sheet (MSDS) which manufacturers and formulators are required to develop for any product (and its ingredients) that can be harmful.

- Boiling point is the temperature in degrees Fahrenheit or Centigrade at which liquid boils (or becomes gas). With mixtures, ranges are given.
- ° A high vapor pressure indicates that a liquid will evaporate easily. Look for the words "evaporate easily". Look for the word "volatile". This is important because they indicate that air concentrations can build up quickly when the substance is worked with in liquid form.

Materials with high vapor pressure can be especially hazardous in an enclosed area or in an area with poor air circulation.

Materials with lower vapor pressures may also pose an inhalation hazard because different methods of handling - spraying as opposed to brushing, for example - can affect the concentration in the air.

A vapor pressure always has to list a temperature.

" Vapor density is the relative density or weight of a vapor or gas compared with an equal volume of air. If the vapor density of a substance is less than 1, it will tend to rise in the air. If the vapor density is greater than 1, it will fall in the air.

Substances with high densities create a particular problem because they will collect in the bottom of tanks.

- Solubility in water refers to the percentage by weight which can be dissolved in water. Less than 0.1 percent is considered negligible; 0.1-1 percent is slight; 1-10 percent is moderate; more than 10 percent is appreciable, and if it can be dissolved in all proportions, it has complete solubility.
- Appearance and odor may help in identifying the substance, but don't rely on odor to indicate whether there is a hazardous concentration in the air. Some substances can reach hazardous levels and not give off a noticeable odor.
- Specific gravity is the ratio of the weight of a volume of liquid to the weight of an equal volume of water at a specified temperature. If a substance has a specific gravity greater than 1, it will sink in water; less than 1, it will float.
- Percent volatile by volume refers to the percentage of a liquid or solid that evaporates at room temperature. The higher the percentage, the faster the evaporation.
- Evaporation rate is the rate at which the material evaporates compared to ether (which evaporates very quickly) or to butyl acetate (which evaporates very slowly). The data sheet should specify which of the two comparison substances was used.

This information is also useful for the design and use of adequate fire and spill containment equipment and procedures. If the product in question does not pose a fire hazard, this information should be noted on the sheet.

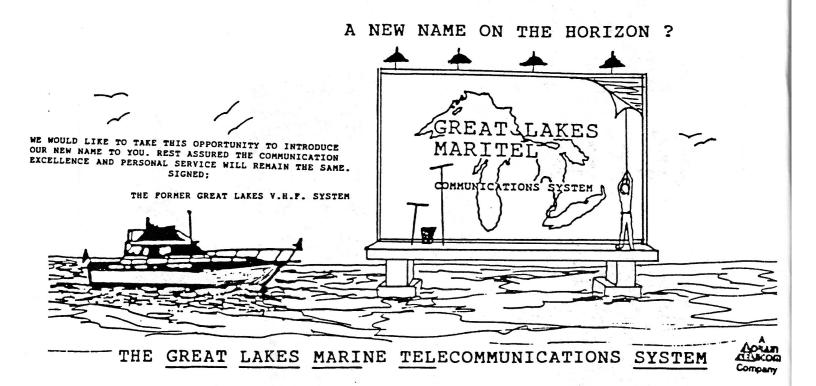

- (6) Press the star key on your M.A.P. 10 pad. This will cause our microprocessor to automatically dial your number.
- (7) When your land party answers their phone you must push button on side of M.A.P. 10 to talk. Release to listen.

NOTE: On completing call replace telephone handset in cradle. This will cause a disconnect and end the billing charge.

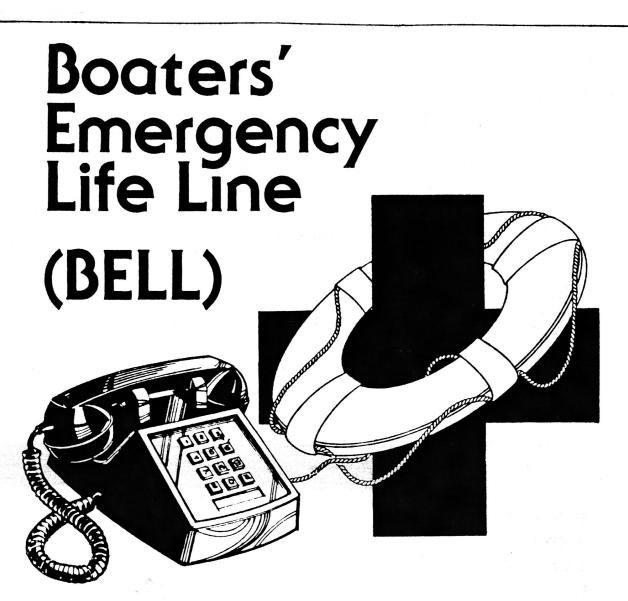
