EXECUTIVE REPORT



If some of your crews are like some of mine, they ask tough questions like "Why do you call it starboard and port sides?" I found the answer in the Ensign. Starboard comes from steerboard, the right side of the boat where Vikings' steering oars were located. Port was the side of a vessel used for coming along-side the dock. It was the left side so the steering oars weren't disturbed.

3 October is the date for our fall land search for Geodetic Marks. You can help your Squadron by joining us in Co-op Charting. Participation helps us to reach our Squadron goals. Reporting the condition of Geodetic Marks to the National Oceanic and Atmospheric Administration gives us tax-free status. And it's fun! Look for P/C Bob Byrne's article in this issue.

Ann Sigford from the Minnesota Sea Grant College Program has asked our Squadron to participate in Superior Lake Watch, a citizen based monitoring program for Lake Superior. They wish for us to conduct water clarity readings for them at pre-arranged places on the lake to monitor algae blooms, rainstorms, and wind events by using a tool, which they supply, called a Secchi Disc. The results over a long period of time helps policy makers with a tool to use in making decisions about management of Lake Superior.

On 6 September, six members of our Squadron conducted six readings between the Wisconsin entry and the Lester River. If you would like to know more about being a "Lakewatcher," please call me, Candy Hengel or anyone on the Executive Committee. Last year a reading was taken on 12 October. Let's get a Duluth Squadron Member to beat that this year. So it's not too late to get involved. Otherwise, we can start you watching next spring.

Jim Marshall, at the Corn Roast on 6 September, said it best. His comment was how great it was to see so many young people and families "involved" in the Squadron. Of the 201 people enjoying the day at the Squadron Dock, 51 were children.

How compatible are you and the FCC? Take the following quiz and see how you score. One point for each "yes" answer.

- A. I have a current FCC station license. If I have radar, the radar frequencies are on the license. It has my current address, and is posted near the radio on the boat.
- B. I always use low power when talking to nearby boats.
- C. I always use my call sign at the beginning and end of each session.
- D. I always check the channels first to see if they are unoccupied.
- E. I know exactly what every channel is for and even carry a copy of the FCC rules, which I have read from cover to cover.
- 0-1 Sign up for Marine Electronics class immediately!
- 2-3 Sounds like you are an average boater, improvement is needed. Read on.
- 4-5 What else do you lie about?

Here is a quick checklist of some channels available for use by recreational boaters:

Ch 16 - Distress and calling channel. Make initial contact on 16, then go to another channel.

Ch 06 - Working channel for safety only, such as boats crossing courses.

Ch 09, 68, 69, 71, 72, 78 - These are working channels for general use by recreational boaters. Some marinas and bridges use these channels also. 09 and 68 are the usual ones.

Ch 12, 14 - These are for communications concerning raising bridges, docking and other "port operations."

Ch 13 - Pilot-house to pilot-house communications. All the large ships are supposed to monitor 13, and can be called directly on 13 for navigational purposes, such as crossing situations. Also used by some bridges as a working channel.

Ch 22 - Coast Guard working channel.

Ch 24 to 28, and 84 to 87. Marine operator channels. Duluth uses 84. Not for other communications.

Channels not mentioned above are generally not for use by recreational boaters. Recently the FCC came out with a ruling allowing recreational boats to use Ch 9 instead of 16 for a calling channel. The purpose is to reduce congestion on 16. My opinion is that congestion on 16 is not a problem around here, continue to use 16 as in the past.






